### **Governor Perdue Appoints Michael H. Womble, CPA, to State Board of CPA Examiners**

**Raleigh**—Governor Bev Perdue has appointed Michael H. Womble, CPA, of Eastover, to a three-year term on the State Board of Certified Public Accountant (CPA) Examiners. Womble was sworn the Oath of Office at the Board's October 18, 2012, meeting.

The Board is an independent State agency that grants certificates of qualification as CPAs to those individuals who meet the legal requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. North Carolina has nearly 20,000 active CPAs.

Womble, who was licensed as a North Carolina CPA in 1987, has more than 30 years of experience in the field of accounting. He is currently a partner with the CPA firm, Williams Overman Pierce, LLP, with offices in Raleigh and Greensboro. He has been involved in many areas of federal and state taxation, accounting and business consulting. He now concentrates primarily on forensic and valuation services, including forensic accounting, business valuation, and litigation consulting and support services.

In addition to his license as a CPA, Womble holds the professional designations of Accredited in Business Valuation (ABV) and Certified in Financial Forensics (CFF) by the American Institute of Certified Public Accountants, Certified Valuation Analyst (CVA) and Certified Forensic Financial Analyst (CFFA) by the National Association of Certified Valuation Analysts, and Accredited Senior Appraiser (ASA) by the American Society of Appraisers. He is a member of the American Institute of Certified Public Accountants, the North Carolina Association of CPAs, National Association of Certified Valuation Analysts, and the American Society of Appraisers.

A former resident of Dunn, Womble's civic and community service includes service as president of the Dunn Chamber of Commerce, chairman of the Dunn Planning Board, a member of the Dunn City Council, and Mayor Pro Tem of Dunn. He is a graduate of Leadership Harnett and received the Distinguished Service Award from the Greater Dunn Jaycees in 1984. He is currently a member of the U.S. Coast Guard Auxiliary.
